

# Membership/Contribution Guidelines

## Contribution Guidelines



Because of differing requirements we ask that you closely examine the table below for contribution limits.

### Federal Contribution Limitation

Individual contribution of \$5,000 per calendar year. A husband and wife each have separate \$5,000 limits

*Corporate checks **may not** be accepted*

### State Contribution Limitation

Individual contribution may not exceed \$100,000 over a 4 year calendar period (1/1/03 thru 12/31/06)

Corporation contribution may not exceed \$100,000 over a 4 year calendar period (1/1/03 thru 12/31/06)

PAC contribution may not exceed \$5,000 (Big PAC may give \$10,000) over 4 year calendar period (1/1/03 thru 12/31/06)

*Corporate checks **can** be accepted*

Cash contributions cannot be accepted. You must indicate on your check whether contribution is for Federal or State Elections. Individual contributions (separate checks) may be accepted for both divisions. Corporate checks cannot be accepted for Federal Elections.

4. My aggregate contributions during the year do not and will not exceed either \$5,000 to the TBIPAC or \$95,000 over a 2 year period (1/1/03 thru 12/31/04 & subsequently 1/1/05 thru 12/31/06) for all federal election contributions.
5. I am 18 years of age or older, an American citizen, or I have been admitted to permanent U.S. residency and this contribution is in my name strictly on behalf of myself.
6. I further agree that I will notify the TBIPAC if any of the above statements are no longer true, or if any of the information provided above changes.
